## PUBLIC NOTICE: RECLAMATION OF CONSIGNMENT GOODS

### 1. PURPOSE & SCOPE

This notice serves as the sole and final formal communication regarding the reclamation of consignment goods currently held by The West Bengal State Handloom Weavers' Cooperative Society Ltd.(Tantuja), hereinafter referred to as "the Society". It applies to all parties who have supplied goods to the Society on a consignment basis and where such goods remain unsold and unclaimed and in the Society's possession as of the publication date.

### 2. MANDATORY RECLAMATION PROCEDURE

To reclaim eligible goods, the consignor/supplier ("the Claimant") must, without exception:

a) **Submission:** Physically deliver a written reclamation request to the Society's office at;

b) **Documentation:** The request should be addressed to The Managing Director and must be accompanied by verifiable supporting documents, which shall include, **at a minimum:**

- i. A detailed, itemized inventory list of the goods being reclaimed, matching the records held by the Society.
- ii. Valid government-issued photo identification of the authorized claimant.
- iii. Proof of authority to act on behalf of the supplying entity (if applicable).

- c) **Deadline:** The complete submission, as defined above, must be received by the Society no later than **5:00 PM on [Final Reclaim Deadline Date]** ("the Deadline").

### 3. CONSEQUENCES OF NON-COMPLIANCE

- i. **Deemed Abandonment:** Any consignment goods not successfully reclaimed through the explicit procedure in Section 2 by the Deadline shall be conclusively deemed abandoned property.
- ii. **Irrevocable Release of Claims:** Upon such deemed abandonment, the Claimant shall be deemed to have irrevocably and unconditionally released, waived, and forfeited all rights, titles, interests, and claims-legal, equitable, or otherwise-in and to the said goods. No future claim for recovery, compensation, damages, or any other remedy shall be entertained.
- iii. **Assent to Disposal:** By failing to comply with this notice, the Claimant is deemed to have expressly assented to the Society's absolute right to dispose of the abandoned goods.

### 3. SOCIETY'S RIGHTS REGARDING ABANDONED GOODS

The Society reserves the exclusive and absolute right, at its sole discretion, to dispose of all goods deemed abandoned pursuant to this notice. Disposal methods may include, but are not limited to, public auction, private sale, destruction, or charitable donation, and shall be conducted in accordance with applicable law and the Society's internal governance rules. All proceeds from any such disposal, net of reasonable costs and expenses incurred by the Society in storage, handling, and the disposal process, shall be the sole property of the Society.

### 4. DISCLAIMERS & ACKNOWLEDGMENTS

By engaging with this reclamation process, Claimants acknowledge and agree that:

- i. This notice constitutes the entire understanding regarding the reclamation of the subject goods.
