1.	The bidder shall be an Indian manufacturer/OEM of Indian National Flags or an authorized bidder supported by an irrevocable tender-specific authorization and production commitment from an eligible manufacturer/OEM. A trader without documented manufacturer support and binding production allocation shall not be eligible (page 2 of 23 and at all other places where the same appears in the Tender Document)	The bidder shall be an entity having its registered office and/or manufacturing unit within the State of West Bengal. The bidder may be: a) A manufacturer of Indian National Flags; b) A manufacturer of similar textile products having adequate production facilities for manufacture of Indian National Flags conforming to the prescribed specifications. c) An authorised dealer, authorised distributor, authorised stockist, authorised marketing agent or authorised representative of an eligible manufacturer. d) A bona fide supplier, trader or business entity having an established and verifiable record of supply of Indian National Flags or similar textile items in bulk to Government Departments, Public Sector Undertakings, Government Agencies, Local Bodies or other reputed institutional buyers during the last three successive financial years ending with 31st March, 2025
2.	The entire quantity allocated to each successful bidder must be manufactured, inspected, packed, dispatched and delivered at the designated consignee locations on or before 09.08.2026 , without any extension (on title page and page 2 of 23 and at all other places where the same appears in the Tender Document)	The entire quantity allocated to each successful bidder must be manufactured, inspected, packed, dispatched and delivered at the designated district headquarters across the state of West Bengal during August 3rd 2026 and August 5th 2026, without any extension.

3.	Similar Supply Experience: during the last five years preceding the bid closing date, the bidder/manufacturer shall have satisfactorily completed supplies of Indian National Flags, flags, made-up textile articles or comparable high-volume finished textile products to Government Departments, PSUs, autonomous bodies, institutional buyers or reputed corporate entities, to the amount of not less than 25% of the estimated tender value. (page 4 of 23 and at all other places where the same appears in the Tender Document)	Similar Supply Experience: The bidder and/or the supporting manufacturer shall have satisfactorily completed the supply of Indian National Flags, flags, made-up textile articles, or comparable high-volume finished textile products during the last three successive financial years ending on 31st March 2025. The average annual value of such completed supplies during the said period shall not be less than ₹2,00,00,000 (Rupees Two Crore only). The above experience shall be supported by documentary evidence such as completion certificates, payment certificates or any other documents considered acceptable by the Tender Inviting Authority.

In addition to the revised terms and conditions incorporated under Sl. Nos. 1 to 4 above, the following conditions shall apply throughout the Tender Document and shall govern eligibility at the Technical Bid stage as well as acceptance of the National Flags at the time of delivery to the designated district headquarters:

4. **Mandatory Participation in Pre-Bid Meeting:** Without prejudice to, and in addition to, the existing eligibility conditions contained in the Tender Document, only those bidders who participate in the scheduled pre-bid meeting shall be considered eligible for technical evaluation. The pre-bid meeting shall be conducted through the Zoom platform on **24th July 2026 at 12:00 Noon.** The decision of the Tender Inviting Authority regarding attendance and participation shall be final and binding.

5. The Indian National Flag shall be manufactured from polyester fabric having a minimum weight of **80 GSM** for both size variants specified in the Tender Document.
